I. PURPOSE OF THE CONFERENCE

The Spanish Association of International Law and International Relations Professors, in collaboration with the University of Las Palmas de Gran Canaria, will hold its next ordinary conference from September 20th to 24th, 2023, focusing on the theme "International Law and International Relations as a Response to the Challenges of the New Globalization".

The program is structured around five 90-minute sessions dedicated to: 1. The new globalization, approaches, and challenges for international law and international relations. 2. Conflict resolution in the era of the new globalization. 3. Economic and energy challenges in times of the new globalization. 4. Relations between States and citizens in the new globalization. 5. Humanitarian, migratory, and refugee conflicts in the era of the new globalization.

Thematic axes for the presentation of communications:

Each session will feature three speakers (20 minutes per presentation), and up to three communications (5 minutes per communication) will be selected for each session to be presented publicly.

The interdisciplinary topics addressed in each session will be related to the challenges of the new globalization that will emerge before us in these times of post-conflict and military difficulties, as well as health, climate, energy, and inter-state and bloc relations. We propose to reflect on how Public and Private International Law and International Relations should serve as a backbone for the management, regulation, and resolution of conflicts of coexistence among States, International Organizations, and citizens through academic debate on the improvement of international relations among the actors of international society.

II. DEADLINE AND SUBMISSION OF PROPOSALS:

Proposals may be submitted from April 15 to May 15, 2023.

To submit a proposal, prior registration on the Conference website is necessary. After registering, a private access will be created for proposal submission, which is confirmed by email. Payment of the registration fee may be made through the link provided on the website, once the acceptance or rejection of the proposal has been communicated.

Formal requirements:

Proposals must be individual, and each person may only submit one communication proposal. However, it is allowed to submit one proposal for communication and one for a workshop, for example.

To submit a proposal, a compressed file (zip/rar) containing three Word documents must be sent:

1. Document containing only the following data: title of the proposal and session to which it is submitted, full name of the proposing person, university of origin, academic position, and reference to membership status in AEPDIRI.
2. Document with the summary of the communication proposal, where the name of the proposing person should not appear, but only the title of the proposal, session to which it is submitted, area of knowledge, its content, and 3-5 keywords. Proposals should have a length between 1000 and 1500 words.
3. Abbreviated CV of the proposing person (max. 3 pages).

Failure to comply with these requirements will result in the exclusion of the proposal.

Content and evaluation:

The Scientific Committee will evaluate the proposals according to the following criteria:

1. Relevance of the chosen topic regarding the theme of the session.
2. Quality of the proposal's development.
3. Originality of the proposal.

The Scientific Committee will select up to a maximum of three communication proposals for oral presentation, one for each area. It will also select up to a maximum of three alternate proposals for oral presentation per session. The Scientific Committee will make a decision on this matter no later than June 19, 2023, by email (please ensure that a valid email address is provided), which will be communicated as follows:

- a) The selection of the proposal for oral presentation at the Conference.
- b) The selection of the proposal without oral presentation and as an alternate.

One communication will be selected per area in each session.

III. PUBLICATION

The acceptance of a communication proposal for oral presentation or as an alternate does not imply acceptance for publication. If the proposing person wishes to include their work in the collective publication resulting from the Conference, they must submit a final text of the communication, which must be sent before September 5, 2023. All written communications will be evaluated by the Scientific Committee for inclusion in the collective work.

The full text must be presented according to the style guidelines of REDI (<http://www.revista-redi.es/es/normas-de-estilo/>). It must not exceed 5000 words and must be submitted in Word, with "Times New Roman" 12-point font for the body text and 10-point font for footnotes.

The final decision on the acceptance or rejection of the communication for inclusion in the resulting work will be communicated before November 1, 2023.
